 - \$90.00/Kva purchased
 - \$0.10/Kw hour of consumption
- Water:
 - \$2.57 per cubic meter
- Natural Gas:
 - \$4,964 connexion fee.
 - \$4.23 per Gcal





Middle of the Scale

rate of exchange: \$13.50 pesos to \$1.00

Base Salary	\$ 2.97 per hour
Social Security	\$ 0.83 per hour
Market Benefits	\$ 1.60 per hour
Cost per hour.	\$ 5.40 per hour





COSTS cont. Bottom of the Scale

Base Minimum Salary	\$ 0.51 per hour
Social Security	\$ 0.14 per hour
Market Benefits	\$ 0.60 per hour
Cost per hour.	\$ 1.25 per hour

Lease of industrial space	\$4.25 - \$5.50 square foot per year
Hotel Construction	US\$40 – US\$120 per square foot

 - •Multiple entry non-permanent resident visa.
 - Valid for 30 days.
 - Limited to US and Canadian nationals.
