BICYCLE RELEASE FORM FOR RESORTS/HOTELS

- I am an experience cyclist and realize all the risks that come with cycling on and off road. I know enough about bicycles to see that these bikes I am about to use are in proper mechanical conditions.
- I understand that [hotel] does not provide insurance coverage for these bikes, and I am taking sole responsibility for my actions. I understand that many unexpected things may happen while riding a bicycle including, but not limited to chain breaks, cable breaks, hitting rocks, trees, or loose ground such as sand. Any of these may cause loss of control of the bicycle resulting in injury or death. [Hotel] cannot be held responsible for injuries.
- I intend that this agreement is binding on my estate and heirs.
- I agree that if I injure anyone while using the bike, and as a result [hotel] is sued, I agree to indemnify [hotel] for all costs of suit and damages, which are incurred by them in defending said action.
- I recognize that the use I make of this bike is my own responsibility. I agree that I will not bring any action against [hotel] for any injuries I sustain as a result of using this bike. I know the bike is assigned to me and I agree that I am the only one that will use the bike.
- I realize that I am responsible to know and follow the laws and rules of the road and that I am liable for consequences of violations and payment of any resulting fines or assessments.
- I understand that these bikes are not equipped for extended descents. I as the renter will be held responsible for any damage or excessive wear to the bicycle due to misuse.
- **I understand that bike use is on a first come, first serve basis. Bikes cannot be reserved. Bike keys must be returned to a hotel agent when bike is not in use. Bikes held for more than 15 minutes without use will be reclaimed by a hotel representative.**
- I also give [hotel] permission to charge me the full retail value for any loss or damage to the bikes and/or accessories while in my possession. A cleaning charge may be charged if bicycles or accessories are returned excessively dirty.
