Hotel Policy

Welcome to _____ and thank you for giving us the opportunity to house your group. To ensure the comfort of all guests staying in the hotel this weekend, please sign the hotel policy whereby you will accept full responsibility for the children in your group room block.

- ◆ **Curfew for the children is 10:00pm.** Any child found after 10:00pm not accompanied by an adult will be escorted to the front desk by security. An adult will have to come to desk to get the child.
- ◆ No running, shouting, loud noises or rough play are acceptable in the hallways, lobby, or stairwells.
- ◆ No glass is allowed in the pool or spa area.
- ◆ Fitness Facility is for those 18 years and older.
- ◆ No sport balls are permitted inside the hotel.
- ◆ Shoes with cleats are not to be worn in the hotel at any time.
- ◆ Your room is initially stocked with enough towels for each person in the room. If you need additional towels, we ask that you allow us to pick up your used towels in exchange for a clean towel, so that we will be able to provide clean towels throughout the weekend.
- ◆ Fire alarms are for emergency only! Intentional false fire alarms are a felony in _____ County and will be fully investigated by the Fire Marshall.
- ◆ Should the hotel experience any damage to the guest rooms, due to misuse, a charge for repair will be introduced.
- ◆ Please adhere to the dress code in the restaurant and lobby. Shoes and shirts please.
- ◆ We are a (state alcohol beverage commission) establishment, therefore only alcohol purchased from the hotel is allowed to be consumed in the lounge or restaurant area. Alcohol brought in from the outside is not permitted under (state) law.
- ◆ No pets allowed. If a pet is reported in your room, a \$100.00 non-refundable cleaning fee will be posted to your bill.
- ◆ Check in time is 4 pm and check out time is 12 noon. Any departure between 12pm and 2pm will be charged ½ days rate and tax. Any departure after 2pm will be charged a full day's room and tax.

Parents and Chaperones, please take time to read this to your team. We ask that you be responsible for the children in your block and ensure they observe the hotel policy for the comfort and safety of all hotel guest.

We want you to have a good time and enjoy your weekend. With your help in ensuring your children are following these policies all of our guests can enjoy their stay. Failure to adhere to this policy will result in eviction from the property.
