## 4. Help us Help You

- Time get us out there quickly (if possible)
  - There can be changes to the area that might make a late inspection difficult
  - Even changes such as a new cleaning contractor can cast doubt on a late inspection
- If not possible, take "good" photographs AND measurements (CG to use Grocery Store Examples)...Document!
- The more relevant information, the better
- Expert desk review or inspection to understand issues before they escalate (get in front of the case) helps you learn to "speak the same language" as

opposing party (why do they think there's a problem, and how do we address it)

- 5. What does the Plaintiff claim was wrong?
  - Incident was "foreseeable" and therefore there should have been protective barriers in place (i.e. bollards). The drive aisle lined up with the store/ADA ramp...
  - For a few thousand dollars, Incident could have been avoided, therefore, you were not a responsible property owner
  - Other properties have barriers, therefore you should have had them to
  - There were no protective barriers in place to prevent a car from jumping a curb
  - Failure to affirmatively act and cure the dangerous condition
  - Failure to affirmatively act and warn Plaintiff of said dangerous condition
  - Failing to affirmatively act and inspect the pool and surrounding common areas for dangerous conditions
  - Failure to put proper warnings in place
  - Failure to notice and act immediately

#### Case Studies

- Chris Premises Liability Cases highlight examples of effective use of expert early in case
  - Auto Parts Store Jackson, MS driver had seizure and drove up ADA ramp into store, striking a patron that was walking in the front door
  - Mall, Raleigh, NC Driver had a sudden, unintended acceleration of vehicle and drove up and over a curb, injuring someone who was sitting at an outdoor seating area at a restaurant
  - Mall, Greeley, CO driver had seizure and drove into a store, fatally injuring two women
  - Restaurant in Coeur d'Alene, ID Teenager walking in a parking lot dives into a hedgerow of bushes and falls down a stairwell that was located on the other side of the bushes, causing a brain injury
  - Wheel stop trip and fall(s)
  - Outdoor restaurant area, Santa Ana CA Patron busses her own table and then sits, when a leg of her chair goes into a planter, causing a fall and broken wrist
  - Pharmacy, Houston TX patron is walking and falls trip is claimed, but dynamics are those of a slip.
  - Electronics Store, Tampa FL Patron entering store is struck by automatic door, claims injuries
  - Hotel, Las Vegas NV Man coming out of the shower falls after shower door fails. Starts as injury consistency, then changes into foreseeability of door failure
