Dear Parents:

It is imperative that groups with young adults/children are chaperoned **at all times**. This request is for the safety and comfort of all of our guests. We would appreciate your attention to the following:

- To ensure guest's safety, there will be no more than 5 people to a room, and there will be no rollaway beds available to rooms with two queen beds.
- At all times there should be NO RUNNING in the hotel hallways and LOUD conversations should be kept to a minimum. One warning will be given for any noise complaint. If the problem continues, the person(s) in the room(s) that received the complaint will be evicted from the hotel without refund.
- CHAPERONES will be responsible for the group during their stay. Unattended children in guestrooms or any public space will be detained at the front desk and may be handled by local law enforcement.
- In-room phones and movies will be turned off unless authorized by an adult. Additional charges incurred for items in the hotel Market or breakfast area are the responsibility of the adult or chaperone in the party.

POOL AND SPA RULES AND REGULATIONS The pool area is open from 6:00am to 11:00pm daily. There is NO lifeguard/attendant on duty. The state health department governs local hotel pool usage and the following guidelines are strictly enforced:

- NEVER SWIM ALONE - A minimum of two adults, 18 years of age or older, must be present whenever the swimming facility is in use. At least one adult must be on deck at all times.
- THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION - Children under 16 years of age must be accompanied by an adult while in the swimming facility (an adult who is responsible for the children and their behavior).
- Only use the swimming facility during posted hours of operation.
- **Children under the age of 16 are not allowed in the spa at any time.**
- Pool and spa usage is limited by occupancy and provided on a first-come/first-served basis. Please be considerate of other guests. The hotel reserves the right to close the pool down should pool occupancy reach a level considered unsafe.
- Do not drink alcohol and swim.
- Use of the pool area is restricted to registered guests only. We do not host parties of any kind in the pool area and ask that all guests refrain from bringing food or beverage into the pool area. Glass containers are prohibited by code.

The safety and security of our guests is very important to us. Therefore, we ask that you adhere to these rules as well as the rules posted in the swimming facility to ensure a safe, pleasant experience. If you have any questions on this policy, please ask to speak with a manager.

CODE OF CONDUCT (Liability for unacceptable behavior) It is Marriott's desire to provide a safe and relaxing atmosphere for our guests. To that end, Marriott requires that all guests adhere to a code of conduct that ensures that noise is kept to a reasonable level and unacceptable behavior is curtailed. The Marriott code of conduct includes but is not limited to excessive noise, intoxication, vulgar language, or activities that cause damage to hotel property or the property of another guest. **The parent of each child agrees to Marriott's code of conduct. After 9 pm any minor must be accompanied by an adult in any public area.**

In the unlikely event that you fail to adhere to Marriott's code of conduct, Marriott reserves the right to ask the violators of Marriott's code of conduct to vacate the premises. Violators will be given one warning that their activities are in violation of the code of conduct. Additionally, should Marriott incur additional cost associated with the unacceptable behavior, Marriott reserves the right to seek reasonable restitution from the registered guest violating Marriott's code of conduct.
